NOTE: Membership dues currently run approximately \$350-\$500 per year, which includes all group publicity, brochures, and mailings. An initial payment, usually \$300, is due at the January meeting, and further payments are made during the year as cash flow needs require.

CAPE ANN ARTISANS STUDIO TOUR Membership Agreement

I understand that the *Cape Ann Artisans Studio Tour* group is a cooperative which involves a deep commitment and important responsibilities. In exchange for being included in all promotional materials, advertising, and referrals from other members of this group, I agree to fulfill the following responsibilities:

- 1) To commit myself to membership for a minimum of one year.
- 2) To give notice by October 31st if I will be resigning my membership.
- 3) To pay annual fees, such as advertising costs, etc. to the treasurer in a timely manner.
- 4) To annually submit current photographs via Dropbox and descriptions of my work for use in the brochure, postcard, and publicity, as requested.
- 5) To play an active role in the cooperative group by doing the following:
 - a) Attend all meetings or contact another member to be my proxy.
 - b) Find out what happened at meetings I missed.
 - c) Provide the group with an up-dated mail-list in a timely fashion, plus email address of contacts.
 - d) Distribute brochures to assigned locations and keep those locations stocked.
 - e) Willingly work with others in the group to promote the Artisans.
 - f) Play a positive and involved role in any way I can.
 - g) Find a replacement for myself if I am unable to do my volunteered job.
- 6) To understand and follow the bylaws of the tour group.
- 7) To maintain throughout my membership the same level of quality, presentation, and originality in my artwork that was displayed when I first was juried into this group.
- 8) To maintain courtesy and professionalism toward all members of the Cape Ann Studio Tour, its affiliates, and its customers.
- 9) To familiarize myself with each artisan in this group and learn about their work in order to help prospective customers.

I understand it is only through my full cooperation that we can truly have an artisans' cooperative founded on mutual respect and recognition of each other's talents and abilities. I completely understand what is expected of me and I will follow all of the current bylaws and help develop new ones that are in this group's best interest.
